Terms and Conditions

1. Below are the Terms and Conditions of participation for the Design Time with Shaynna Blaze Promotion (**Promotion**) including eligibility, age limits, exclusions and the details of how to enter the Promotion.
2. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this Promotion constitutes acceptance of these Terms and Conditions.
3. The Promoter means BSH Home Appliances Pty Ltd (ACN 109 198 405) of 1555 Centre Road, Clayton, Victoria, 3168, telephone 1800 037 772 (**Promoter**).
4. **Eligibility:** Entry is only open to Australian residents with a residential address in Australia, aged 18 years or over who have purchased two or more Eligible Products within the Promotional Period (as defined below) (**Eligible Entrant**). Employees (and their immediate families) of the Promoter and agencies associated with this Promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or, first cousin.
5. **Promotional Period** means the period commencing 30 July 2021 until 19 September 2021.
6. **Eligible Products** means two or more Bosch Major Cooking Appliances (i.e. Bosch cooktops, range hoods, coffee machines, ovens, warming drawers, freestanding cookers, microwaves, fridges, freezers and fridge-freezers only), from an authorised reseller in Australia that is currently listed on the Bosch Home Appliance website (www.bosch-home.com.au).
7. **Entry:** To enter, Eligible Entrants must do the following: **(a)** purchase two or more Eligible Products during the Promotional Period, paid for in full; and **(b)** by 26 September 2021, correctly fill in and submit the online entry form located at boschpromotion.com.au/ShaynnaBlaze including answering the following question in 50 words or less:
Why would you like Shaynna Blaze to help you with your next design project?
8. All entrants must submit only their own original answers. Any such answers cannot be previously published in any forum worldwide. All entries become the property of the Promoter and cannot be returned. The Promoter reserves the right in its sole discretion to disqualify any individual who the Promoter has reason to believe has breached any of these Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the Promotion.
9. Entrants must include a copy of their original invoice in the online entry form which clearly shows the purchase of two or more Eligible Products within the Promotional Period.
10. **Nature of the Promotion:** Ten winners will be selected by a judging panel, having regard to the skill, creativity and originality of the answers, at the Promoter's premises on 30 September 2021.
11. The judging panel will consist of representatives from the Promoter.
12. The Promoter reserves the right to alter the make-up of the judging panel if a judge becomes unavailable at any time.
13. Winners will be notified by telephone and e-mail using the contact details provided to the Promoter at the time of entry into the Promotion, and their name will be published on the Promoter's website www.bosch-home.com.au/promotions on 30 September 2021.

14. The Promoter may select additional entries to be used as replacements in the event that a winner cannot satisfy these Conditions, receive / attend the Prize or, fails to claim the Prize by 14 October 2021.
15. If for any reason a winner does not take a prize, then the prize will be forfeited.
16. Multiple entries are not permitted, only one entry per person.
17. **Deadline:** Entries must be received by the Promoter by 11:59pm AEST on 26 September 2021. Entries received afterwards will not enter the Promotion. The Promoter accepts no liability for entries that are delayed or not received.
18. **Verification:** The Promoter reserves the right, at any time, to verify the validity of entries and Eligible Entrants (including an Eligible Entrant's identity, age and place of residence). Any misrepresentation or fraudulent information supplied by an entrant disqualifies their entry. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
19. Incomplete or indecipherable entries will be deemed invalid.
20. **Discretion:** The Promoter's decision on all matters pertaining to the Promotion is final and binding and no correspondence will be entered into, except as otherwise stated in these Terms and Conditions (if at all).
21. **Prize:** Ten entrants will be: **(a)** win one \$2,000.00 Freedom Gift Card; and **(b)** participate in a Design Time Master Class run by Shaynna Blaze (**Prize**).
22. Design Time Master Classes will be held on 13 November 2021. Each winner will participate in one of two Design Time Master Classes (one morning session or, one afternoon session). The Promoter will allocate winners to the morning or, afternoon Design Time Master Class. Winners will be invited to bring one guest to their allocated Design Time Master Class. Design Time Master Classes will be held at the Bosch Showroom – 1555 Centre Road, Clayton, Victoria 3168.
23. Winners residing outside of the State of Victoria will be provided two domestic return economy airfares. Winners residing outside of the State of Victoria will be provided two nights' accommodation in a minimum 4 star hotel and hotel transfers up to the value of \$1250.00. Any other elements e.g. spending money, meals, additional transport, transfers / taxis, insurance and all other ancillary costs incurred as a result of taking the Prize, unless specified as included, are not included and remain the responsibility of the winner(s).
24. Winners will receive the \$2,000.00 Freedom Gift Card during their allocated Design Time Master Class.
25. If for any reason a winner does not take / redeem a Prize (or an element of the Prize) by the time stipulated by the Promoter, then the Prize (or that element of the Prize) will be forfeited. Winners must allow up to 28 business days from the date they provide their full delivery details to receive the Prize.
26. The Promoter will use reasonable efforts to deliver the Prize, or any portion of the Prize within the specified time frames. However, the Promoter is not responsible for delays, which are caused by events beyond the control of the Promoter.
27. The total value of the Prize is available to the winners at the discretion of the Promoter.
28. If any Prize (or part of any Prize) is unavailable, for whatever reason, the Promoter, in its discretion, reserves the right to substitute the Prize (or that part of the Prize) for a Prize to the equal value and / or specification, subject to any written directions from a regulatory authority. It is a condition of accepting the Prize that winners must comply with all the conditions of use of the Prize and Promoter's requirements. Each Prize must be taken as stated and no compensation will be payable if a winner is unable to use the Prize as stated.
29. **Transferability:** Prizes, or any unused portion of a Prize, are not transferable, assignable or exchangeable and cannot be taken as cash, cheque or electronic transfer.
30. **Modifications:** If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law: **(a)** to disqualify any Eligible Entrant; or **(b)** subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the Promotion, as appropriate.
31. Any cost associated with accessing the Promotional website is the Eligible Entrant's responsibility and is dependent on the internet service provider used.

Implied Guarantees:** Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act 2010 (Cth), as well as any other implied warranties under any other similar consumer protection laws in the States and Territories of Australia (**Non-Excludable Guarantees**).
- 33. Liability:** Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: **(a)** any technical difficulties or equipment malfunction (whether or not under the Promoter's control); **(b)** any theft, unauthorised access or third party interference; **(c)** any entry or Prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; **(d)** any variation in Prize value to that stated in these Terms and Conditions; **(e)** any tax liability incurred by a winner or Eligible Entrant; or **(f)** use of a Prize.
- 34.** The Promoter and its agencies and companies associated with the Promotion will not be liable for any damage in transit of any Prize.
- 35. Privacy:** The Promoter collects Personal Information (**PI**) in order to conduct the Promotion and may, for this purpose, disclose such PI to third parties, including but not limited to agents, contractors, service providers, Prize suppliers and, as required, to Australian regulatory authorities. Entry is conditional on providing this PI. The Promoter will also use and handle PI as set out in its Privacy Policy, which can be viewed at www.bosch-home.com.au (follow the 'Privacy' link). In addition to any use that may be outlined in the Promoter's Privacy Policy, the Promoter may, for an indefinite period, unless otherwise advised, use the PI for Promotional, marketing, publicity, research and profiling purposes, including sending electronic messages or telephoning the Eligible Entrant. Any misrepresentation or fraudulent information supplied by an entrant disqualifies their entry / entries. The Privacy Policy also contains information about how Eligible Entrants may opt out, access, update or correct their PI, how Eligible Entrants may complain about a breach of the Australian Privacy Principles or any other applicable laws and how those complaints will be dealt with. Unless otherwise indicated by the Promoter, the Promoter may disclose PI to entities outside of Australia (for a list of the countries, see the Promoter's Privacy Policy).

- 37.** A term (or part or parts thereof) of these Terms and Conditions will not apply where the term is unenforceable under the law of the relevant jurisdiction under which any legal action is legitimately taken, however such terms (or part or parts thereof) are severable and do not invalidate the remaining terms.
